# Customs declaration for battery cabinet





#### **Overview**

Do lithium batteries need a customs declaration?

As a special kind of cargo, lithium batteries need to follow strict regulations and requirements during the export process to ensure that they are safely and compliantly transported to the destination. When conducting customs declaration for lithium battery exports, it is crucial to prepare complete and compliant documents.

What is a customs declaration & registration certificate?

Basic customs declaration documents Import and export operation rights and self-inspection registration certificate: These certificates are key documents proving that the exporter has legal import and export qualifications and self-inspection capabilities.

How to prepare a lithium battery export document?

When preparing documents, follow the following steps: Confirm export requirements: Need to confirm the import requirements and standards for lithium batteries of the export country and region, including requirements for product quality, labels, packaging, etc.

What documents are required for export customs declaration?

Documents required for export customs declaration: including list, invoice, contract, verification form, customs declaration power of attorney, shipping company's loading list, etc. These documents are the basis for customs to conduct cargo supervision and statistics, and also the basis for exporters and importers to conduct trade settlement.

Why are import declaration form and export declaration form numbered?

The Import Declaration Form and the Export Declaration Form shall be numbered respectively to ensure that each declaration form of the customs district can be uniquely identified by import and export within the same



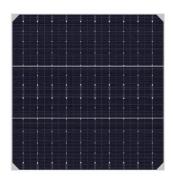


