Overview

What was the EU export value of solar panels in 2023?

The EU import values of solar panels and liquid biofuels in 2023 were much higher than the corresponding EU export values which were €0.9 billion for solar panels and €2.2 billion for liquid biofuels. By contrast, the EU export value of wind turbines in 2023 (€2.0 billion) was much higher than the corresponding value for imports.

What is the EU export value of wind turbines in 2023?

By contrast, the EU export value of wind turbines in 2023 (€2.0 billion) was much higher than the corresponding value for imports. The EU import value of solar panels decreased by 12% between 2022 and 2023 (see Figure 2), due to a drop in prices, even though the quantity imported slightly increased by +5%.

How big is EU PV glass production?

Total EU PV glass production throughout the investigation period has been estimated at around 12 million square meters. The Chinese government initially participated in the first consultation phase of the review process, but later decided not to cooperate, the European Commission said.

Which countries import wind turbines & solar panels in 2023?

In 2023, China was the largest origin of extra-EU imports of wind turbines, solar panels and liquid biofuels. In 2023, the United Kingdom was the largest destination for extra-EU exports of wind turbines and solar panels, the United States for liquid biofuels.

Should China scrap anti-dumping and Countervailing Measures on solar glass imports?

The European Commission has concluded that there are no compelling reasons to scrap definitive countervailing and anti-dumping measures on solar



glass imports from China. Currently, the anti-subsidy duties range from 3.2% to 17.1%, while anti-dumping tariffs are between 17.5% and 75.4%.

How did the US & EU trade war affect solar PV?

• The trade war of the early 2010s on solar PV initiated by the US and European Union (EU) triggered a major wave of bankruptcies in China that proved to be a temporary setback for the industry. China's efforts to stimulate domestic PV deployment sustained the industry's growth and drove rapid cost reductions for Chinese-manufactured modules.





